 - a. Approval of Renewal of Cooperative Endeavor Agreement with Ascension Chamber of Commerce. Ascension Chamber of Commerce will assist in advocating for the Infrastructure and Industry Coalition, the Parish, Industry, and community leaders to State Officials and assist and support the promotion and advancement of the various projects as a critical infrastructure need and statewide economic driver, and participate in appropriate Legislative Committee and Department of Transportation and Development meetings. Ascension Parish Government will provide funds not to exceed \$48,000.00 (Donnie Miller, Ascension Chamber of Commerce)
 - b. Presentation of the Class of 2026 Leadership Ascension Teams/Projects and approval to allocate \$10,000.00 appropriation to support all Leadership Ascension Teams/Projects (Amy Velez, Ascension Chamber of Commerce and (1) Representative from each Leadership Ascension Team Class of 2026)
 - c. Approval of Renewal of Cooperative Endeavor Agreement with Nicholls State University to manage operations of the West Ascension Early Learning Center. Contract amount not to exceed \$1,200,000.00 (Colleen Arceneaux, Director Health and Community Development)
 - d. Approval of Cooperative Endeavor Agreement with Love Impact Coalition, Inc for a one-time payment of \$100,000.00 to assist with provision of free healthcare services at two (2) free medical/dental/vision clinics in Ascension Parish, one in Donaldsonville and one in Gonzales (Colleen Arceneaux, Director Health and Community Development)
 - e. Approval of Ordinance declaring surplus and authorization of the sale and/or transfer of miscellaneous movable equipment (Lynda Timmons, Senior Accountant II)

- f. Approval of Renewal of Master Services Agreement with Clean Earth of Alabama, Inc. for the collection of hazardous household material for a term of two years. Total compensation shall not exceed \$300,000.00 (Jade Robin, Director Drainage Operations)
- g. Approval of Amendment No. 1 for the Geotechnical Assistance Contract with Gulf South Engineering and Testing, Inc., to add an additional \$200,000.00, for a new amount not to exceed \$350,000.00 per calendar year. Gulf South Engineering and Testing, Inc. will only receive a portion of the total amount, dependent on the task orders awarded and provided (Randy Mullis, Director Project Management)
- h. Approval of Amendment No. 1 for the Geotechnical Assistance Contract with Terracon Consultants, Inc., to add an additional \$200,000.00, for a new amount not to exceed \$350,000.00 per calendar year. Terracon Consultants, Inc. will only receive a portion of the total amount, dependent on the task orders awarded and provided (Randy Mullis, Director Project Management)
- i. Approval of Amendment No. 1 for the Geotechnical Assistance Contract with Ardaman & Associates, Inc., to add an additional \$200,000.00, for a new amount not to exceed \$350,000.00 per calendar year. Ardaman & Associates, Inc. will only receive a portion of the total amount, dependent on the task orders awarded and provided (Randy Mullis, Director Project Management)
- j. Approval of Intergovernmental Agreement between Ascension Parish Government and the City of Donaldsonville. Ascension Parish Government will grant permanent servitudes to the City of Donaldsonville for the construction of a proposed sidewalk along Thibaut Drive and Clay Street in Donaldsonville, LA. The City of Donaldsonville shall assume maintenance of the sidewalk at its expense (Daniel Helms, Director Transportation)
- k. Approval of Cooperative Endeavor Agreement between Ascension Parish Government and the Louisiana Department of Transportation and Development (LADOTD) for the LA 73 Roundabout at Bluff Road Connector Project, H.014918, and approval for Parish President Clint Cointment to execute the Agreement (Daniel Helms, Director Transportation)
- l. Approval of additional funding for CSRS, LLC for design and support services for the Energy Transition Parkway Phase II and IIA Projects (Contract 250176); Contract value will increase by \$114,500.00 for a not to exceed value of \$464,500.00 (Daniel Helms, Director Transportation)
- m. Approval to accept the lowest responsive quote in the amount of \$158,314.99 submitted by HydraTec Services for the FY 2024-2025 Purchase and Install Isolation Valves in Public Water Drinking System Project and to authorize the Parish President to enter into a contract for the project (Dean Thomason, Project Manager III)
- n. Approval of Amendment No. 4 to the Master Contract for Professional Services with McKim & Creed, Inc. for the Water Sector Program, to extend the Contract to July 31, 2026, and is retroactive to May 31, 2026. The Amendment only extends the term of the project and does not affect the original contract price (Dean Thomason, Project Manager III)
- o. Approval of Amendment No. 3 to Legal Services Contract with Daigle, Fisse, and Kessenich to increase the contract by \$100,000.00 for a total contract amount not to exceed \$495,000.00 to continue representation in general legal matters through April 22, 2026 (Jean-Paul Robert, Parish Attorney)
